Universal Sompo General Insurance Company Ltd for all registered students of the Institute from July 23, 2024 for a period of one year. The list of Institute empanelled hospitals at Indore and details of the Insurance agency is attached for your kind reference.

Each student will be provided with a unique Health ID (UHID). It will be uploaded shortly in the Student Affairs webpage and an email will also be circulated to all students. Having UHID is mandatory to avail the medical insurance benefits. However, in case you need to undergo any IPD treatment before the issue of UHID, you may approach the Institute empanelled hospitals with your student ID card issued by the Institute.
